




Location of Edgehill Lakes:

From Augusta: Take US Highway 1 South (Deans Bridge Road) to the city of Wrens. In Wrens at the downtown intersection turn right onto State Highway 102 towards Stapleton and Avera. Follow Hwy 102 for 9 miles through Stapleton and into Avera. In Avera turn left at the caution light in front of the Avera Shopping Center. Travel 0.1 miles to the next intersection. Turn right onto the Edgehill Avera Road. Travel a distance of 5.8 miles to Barford Road. Turn left onto Barford Road for a distance of 0.8 miles to ECC Mine Road. Turn left and follow ECC Mine Road approximately one mile to the property on both

From Atlanta: Take I-20 to the Norwood Exit of I-20 at mile marker 150. Turn right towards Norwood and Warrenton on Highway 278. Follow Highway 278 for a distance of 10.6 miles through the city of Norwood and into the city of Warrenton. 




Restrictions for Edgehill Lakes:

The following covenants will run with the land for a period of 10 years from transfer title for all Lots in Edgehill Lakes:
